Could YOU Be Owed Money?

Your tax code tells your employer how much tax to take out of your wages every month. If at any point in the last four years HMRC has sent your employer the wrong code, you could have been paying more tax than necessary.

Over 1 in 3 people who have applied for a tax code review have received a tax refund.

Since 2009, 3,448 ASCL members have applied for a tax code review, with the average refund being £445.

The fee for refunds up to £100 is $£38^*$ and for refunds over £100 the fee is 38p for each £1.

*If your refund is under £38, the minimum fee will be reduced to the same value as your refund so you will have nothing more to pay.
